Question	<b>Are any of you planning on wearing a mask to preach?</b>  <b>Answers:</b> I am the worship pastor and I will be wearing a mask off the platform, but to lead worship I will remove my mask and that is what our interim pastor is planning on doing as well to preach. We are also blocking off the first three rows (about 20 feet from the stage) or so from the stage to prevent spreading.  Not preaching in a mask. Will wear one whenever not on platform
Question	<b>Are there any guidelines regarding ordinances? Baptism specifically?</b>  <b>Answers:</b> Guidelines have not been printed, but the idea is that water will have to be changed between candidates.  From a chemical engineering standpoint... keep baptismal water above 3 ppm and less than 6 ppm. free chlorine
Question	How do you best interpret the “red lettering” at the top of the document, specifically “these guidelines are to be followed to open and REMAIN open?”
Question	<b>Anyone know what the guidelines are for the children to return on June 15th?</b>  <b>Answer:</b> No. They will be consistent with daycare guidelines, which haven't been released yet.
Comment	We had 230 folks take our survey. 45% will return the first week but 2/3 of them have concerns about returning.
